PACKED RESIDENTS MEETING

FROM THE ONE SILK STREET CAMPAIGN GROUP

It was standing room only at St Giles on a rain-soaked 22 October evening as over 200 residents and neighbours from Golden Lane and Heron rallied against two new Silk Street office towers due for a planning decision early 2026. People from every part of the estate came to be briefed on how to use objections in the most legally relevant way in terms of valid planning points. Deadline for objections is 12 November.

The new twin towers will loom over the Barbican Centre, Speed, Ben Jonson, Cromwell, Andrewes, Willoughby, Gilbert, Frobisher, Brandon and Heron. Gardens, highwalks, lakes, and the Conservatory will have their daylight substantially impacted. The towers will be visible right across the estate and hit Whitecross Street. Air above Silk Street and The Brewery Conservation Area will be grabbed.

Expert advisors and volunteers highlighted inappropriate height and mass; harm to heritage; loss of daylight and sunlight; harm to residential amenity – we will be overlooked in rooms from terraces and with huge light pollution – the noise from years of demolition and build will echo over the estate, but are not grounds for a planning objection, and neither is cut in property values. The damage to the world-renowned Barbican Estate and Centre will directly hit the heritage and culture of the City, hardly helping Destination City! Over 77,000 tonnes in CO2e will be emitted during construction.

Residents asked and gave ideas on how best to counter what is surely the greatest threat to the Barbican in 50 years: our team urged a high number of objections – people within households can submit individual objections; get friends and contacts to support our @silkstreetcampaign, and with funds. Media is also being briefed

The Silk Street Campaign wants a visionary world class scheme right for its locality.

SEPTEMBER SUMMARY

There were only 9 reported ASB incidents during September as compared to 21 reported for the same period last year.

A report based on 12 months data June 2021 to June 2022 together with findings & recommendations of the Barbican Estate Security Committee has been provided to appropriate Corporation Members & Officers and discussions are ongoing – as an initial outcome a Task/ Finish Joint Action Group was formed and met, just once, in December 2022.

This group has since been replaced with a new "ASB Strategic Meeting". Unlike the previous group, however, this is not an open meeting – Decision taken in February 2023 for BEO's Residents Service Team to produce an information leaflet for residents, revisiting and advising them of who to contact, for which type of anti-social behaviour. Not produced.

Dan Sanders, Director of Property & Estate Management for the Barbican has advised that other proposals are now being considered and should be formulated in the near future.

Meantime, please continue to report any anti-social behaviour you may witness occurring across the estate. Any crime, such as phone, bag or laptop snatching should be reported directly to the City of London Police and not included in the ASB Reporter.

Please remember that the intention of the ASB Reporter is purely to gather evidence of anti-social behaviour. Therefore, if you witness an ASB incident please use the website to record the event but if immediate action is also required then you should follow normal procedure such

as calling the Police on 101 (or 999 but only if URGENT);
Barbican Estate Office; City Noise Team etc. If it is the City
of London Police that you call, it is essential that you are
provided with a reference/case number – please include
this case number in the "action taken" section of the
ASB Reporter. IF YOU DO NOT, this incident will not be
"officially" counted and the police will assume that no
additional measures or activity is required.

FUTURE PROOFING THE BARBICAN

CLIMATE CHANGE

In June, the Barbican Association held a workshop to discuss the priorities for the Barbican Association. One of the priorities that came out of this process was "Future Proofing the Estate", with a key focus on reducing energy consumption in the interest of cost, comfort and carbon 'net zero'.

In the October Update we canvassed for those with expertise and experience with retrofitting insulation, roofs, windows, heating and the like, especially for listed buildings to join a working party, and we were delighted that three new members have come forward.

As these aims are similar to those of the RCC Climate and Zero Carbon Working Party, an approach was made and it has been agreed that it would be most efficient to join forces. The RCC Climate and Zero Carbon WP had undertaken much work under the Chairmanship of Ted Reilly but has not met since he left the Barbican and having a wider group of volunteers involved is seen to be a benefit to residents. This is timely in light of the AMBUE project which is being sponsored by the City Energy Team and the BEO, involving sensors and drones to generate calibrated energy models to assess potential measures for residents and the BRC and RCC to consider in due course.

Richard Setchim has agreed to become Interim Chair of the Climate and Zero Carbon Working Party, with David Preston acting as secretary. A meeting is being arranged for those who have expressed interest and previous members of the RCC Climate and Zero Carbon WP will also be contacted.
